Dear Clerk

I hope this message finds you well. I am writing to seek clarification regarding the recent solar panel and battery storage installations at Rugeley Town Council facilities. In a recent meeting, it was mentioned that the installations have "not made any money back" for the town, despite the substantial investment exceeding £100,000.

However, I came across a statement on the installing company's website that presents a contrasting view. According to the information provided, the council has experienced significant savings on its energy bills following the installation. Specifically, it was mentioned that there was a 54% saving compared to September 2022 and a 57% saving from the bill compared to June 2023.

Given the discrepancy between the discussions in the town council meeting and the information advertised by the installation company, I believe it would be beneficial for the council and the community to have a clear and transparent understanding of the situation.

Could you please provide a public statement clarifying the following points?


- 1. The actual financial impact of the solar panel and battery installations on the council's energy expenses.
- 2. The reasons behind the difference in the reported outcomes between the council meeting and the installation company's statement.
- 3. Any additional context that would help the residents of Rugeley understand the situation better.

The residents of Rugeley are keen to understand the return on investment from such sustainable initiatives and ensure that public funds are being utilized effectively.

Bruno Peek CVO OBE OPR, Pageantmaster, provides insights into the arrangements for the upcoming D-Day 80th anniversary, and how local councils can actively participate.

D-Day history and commemoration

6 June 2024, marks the 80th anniversary of D-Day and the beginning of Operation Overlord, the most extensive naval, air, and land operation in history, involving the landing of around 156,000 Allied troops in Normandy, with some 130,000 of them touching down on the beaches of Normandy, as they sought to recapture Western Europe from the Nazis.

To honour the bravery and sacrifice of all those who secured the peace and freedom we enjoy today, beacons will be lit around the United Kingdom, Channel Islands, Isle of Man and UK Overseas Territories at 9:15pm on 6 June. This will be followed by an event commemorating what is one of the most remarkable achievements in living memory.

We invite all town, parish, and community councils to join us in lighting beacons and hosting events to remember and honour the hundreds of thousands Allied casualties. This includes the nearly 37,000 ground forces and 16,000 air forces killed in the invasion of Normandy's Utah, Omaha, Gold, Juno, and Sword beaches.

Types of beacons

There are four types of beacons being lit for the occasion:

- Bonfire beacon
- Your D-Day 80 Bishops Frome Strawman
- Beacon Brazier
- Gas-Fuelled beacons

D-Day 80 Lamp Light of Peace

For local councils that would like to take part but are lacking resources or land to light a beacon, we encourage the purchase of a reusable 'Lamp Light of Peace'. A very cost efficient and simple way to take part, the lamp's ruby red colour represents the ultimate sacrifice made by brave men and women across the globe, and its flame the 'light of peace' that emerged from the



darkness of war. We would like these lamps to be lit at the same time as the beacons, and once lit for this occasion, they can be re-lit again at 11am on 11 November in 'Remembrance' for many years to come. The Lamps can be purchased and lit by care homes, hospitals, churches, hotels, pubs and families etc, enabling them to be part of this historic commemoration. 

Redevelopment of the area surrounding the former Rugeley Boardwalk in Brook Square, Rugeley

Draft proposal by Olivia Lyons with support of other Officers and Councillors at Rugeley Town Council (This is for consideration only as a starting point to improve the area surrounding the former boardwalk in Brook Square, further professional guidance to be sought as project progresses)

Location

Based in the heart of Rugeley Town Centre, Rugeley Boardwalk links Brook Square and Brewery Street with the car parks located just off Albion Street.



Level of need

The boardwalk serves as a much-appreciated walkway, connecting two of the main streets and retail areas within the town centre. It was well used, particularly by individuals with families, pushchairs and wheelchair users.

The valuable walkway is much missed by local residents and patrons of the town, clearly evidenced by a petition launched in 2020 signed by over 600 signatories.

History

The original construction was established by Staffordshire County Council and was over 20 years old at the time it was stripped down.

An area of the boardwalk was damaged and sectioned off in early 2018. Following inspection, it was closed due to risk of imminent collapse and, as a result, stripped down.



Funds were earmarked for a new boardwalk by Cannock Chase District Council in their 20/21 budget.

A structural engineer was engaged by Cannock Chase District Council to undertake groundwork and survey the required work, designs were sought, and cost estimates received. The boardwalk came in significantly overbudget — however it had been costed based upon fully replacing the boardwalk with a like for like structure. At this point, it was felt that such an expense was unjustifiable use of public funds when considered against a backdrop of high inflation, inaccessibility of raw materials and a cost-of-living crisis. It was diarised to be reconsidered by the Council in Autumn 2023 when it was hoped that inflation would have begun to fall and alternative bridge structures could be looked at.

In October 2023, the new Cabinet at Cannock Chase District Council reconsidered the boardwalk. A decision was made not to proceed with replacing Rugeley Boardwalk and instead permission was granted to spend the majority of funds previously earmarked for this purpose on replacing bridges in Rawnsley and Hednesford. The remaining funds were reallocated via the general budgetary setting process.

At Cannock Chase District Council Full Council on 8th November 2023, District Councillor for Western Springs Olivia Lyons, tabled a motion during requesting that the new Cabinet at Cannock Chase District Council consider allocating the sum of £35,000 to Rugeley Town Council to be spent towards improving the area surrounding Rugeley Boardwalk, if an appropriate such Scheme could be agreed.

Proposals for a Scheme

In order to restore a pedestrian pathway in the area and enable it to return to being a walkway which links the two distinct areas of the town centre, there must be a crossing over the watercourse. It is proposed that this be a bridge crossing the water, rather than a full boardwalk running parallel to the brook (as previously considered) given that this requires a significantly greater structure.


Initial assessments have been undertaken, and it has been proposed that a new bridge be located to the side of Gardner Champion Solicitors intersecting the watercourse at an angle towards the rear corner of the building currently occupied by Paramount Security Group.





Graphic to illustrate <u>location</u> of proposed new bridge only (this does <u>NOT</u> represent to type or materials proposed for the new structure).

The proposed location of the new bridge means that the crossing will be located in the same area that the entrance to the former boardwalk was located. The markings to the entrance remain marked out by the remnants of the previous structure.



Previous entrance leading across the former boardwalk







Location of entrance onto the former boardwalk from Brook Square taken from Brook.

Side (front) of Gardner Champion Solicitors where proposed bridge will be located.






Side (rear) of Gardner Champion Solicitors where proposed bridge will be located.

Bridge

After initial investigations, a simple bridge crossing the watercourse (with additional width each side as previously requested by the Environment Agency) is proposed, similar to the existing bridges located both at both Elmore Park in Rugeley and along the Heritage Trail.

Initial sketch in respect of the type of bridge proposed in the location identified by this report:



Once the exact size and specification has been decided upon by Rugeley Town Council following further investigative works, it is proposed that a competitive process commence to ensure transparency and fair competition.

An alternative option to be considered is a 'footbridge' kit custom made to fit. 'Kit footbridges' can offer value for money given that they are manufactured using readily available timber (hardwood or softwood) to keep costs to a minimum. They are supplied in component kit form and are pretreated to enable a minimum 30 year (softwood) or 40 year (hardwood) service life – they can be vandal resistant, low maintence and economical. They can also be designed to ensure 5kN/m2 (crowd loading).

Kit bridges are delivered with a parts list, assembly drawing and assembly instructions. All components are pre-drilled for quick and easy assembly on site. All fittings are provided. Many such websites include a 'Bridge Specifier Tool'.

Once the structure itself has been decided upon, the Town Council could engage with local businesses to support the build and ensure all of the required specifications are met.

Companies such as 'CTS Bridges' are familiar and experienced in provided bridges meeting required specifications for local authorities and public organisations. Examples of locations where 'Kit Bridges' are already in place include locations across Sheffield by Sheffield City Council, Blackmoorfoot Reservoir in Huddersfield, Weldon Plant at Barford Wildlife Trust and Scars Gill in the Yorkshire Dales National Park.

Programme

Delivery would be approximately 9 weeks from receipt of order.

This programme does not make allowance for the work load within our factory operations at time of placement of order.

As outlined above, the initial costs are in the region of:

- £11,500 plus VAT for design (by Chartered Civil and Structural Engineers), manufacture and delivery; and
- £3,400 plus VAT if installation on site is required.

Fencing

It is proposed that fencing could be considered as part of the proposed Scheme to run along the waterside, in the areas where the shallow brook is exposed. Different types of fencing could be considered, including tubular metal estate fencing similar to the fencing currently in place around the lake at nearby Elmore Park.

This can be galvanised for an almost maintenance free lifespan and powder coated to match the surrounding aesthetics. Gates, if required, could also been considered.





Landscaping

It is also proposed that the area surrounding the brook be landscaped or designed so as to aesthetically improve the area and provide space for local residents and the public to enjoy, such areas could include seated spaces and benches.

The pathway which formed part of the former boardwalk, once it had crossed the brook, ran along the right side (when facing Brook Square). It is proposed that a new pathway in the same location be considered to enable a formal pathway to be reestablished between Brook Square/Brewery Street and Albion Street.

Proposed new pathway running alongside brook and proposed new fencing.





Red arrow represents location of proposed pathway running parallel to Rising Brook.

It is proposed that the end of the proposed new pathway be located in the same location as the end of the former Boardwalk, towards the car parks leading to Albion Street.





Space representing the end of the former boardwalk, leading to carpark along Albion Street.

Ideas for the surrounding area could include a dedicated environmentally friendly area, such as wildflower borders, which are also considered to be lower maintence.

Rugeley Town Council previously undertook an extremely successful community project which saw the construction of the 'Rugeley Mindfulness Garden' in neighbouring Brook Square, created with the support of a local garden designer and landscaper who created a 3D plan for Rugeley Town Council. It is hoped that the new proposed landscaping and seating areas surrounding the Rising Brook build on this success and compliment the Mindfulness Garden.



Neighbouring Rugeley Mindfulness Garden



The neighbouring Mindfulness Garden focuses on mental health and promoting wellbeing. Following the development of the neighbouring Mindfulness Garden, a local resident-led community group formed to raise awareness of suicide. There is already a public bench dedicated to suicide victims in the neighbouring Mindfulness Garden. The local group, made up of individuals impacted by suicide within their family, has set about arranging a local walk called 'Kai's Memory Miles'. The Group is spearheaded by the mother of a victim of suicide, and, during recent meetings, the Group have expressed an interest of dedicating a space within the vicinity of the former boardwalk area to further raise awareness of suicide locally, in particular youth suicide. This new Scheme could include a peaceful seating area, alongside an appropriate monument or sculpture chosen by the Group.



Funding

It is hoped that Rugeley Town Council can build on the success of the 'Rugeley Mindfulness Garden' which was managed as a community project.

It is proposed that Rugeley Town Council explore various funding streams and grant opportunities for such initiatives, such as those secured for Rugeley Mindfulness Garden. It is also proposed that local businesses be approached, and sponsorship opportunities offered.

Possible funding opportunities to be considered:

- District Councillor for Western Springs Olivia Lyons has requested that the Cabinet at Cannock Chase District Council consider allocating the sum of £35,000 towards the project. This is due to be considered at an upcoming Cabinet meeting in 2024.
- Rugeley Town Council has also been allocated a further sum of £32,436.29 from the Government's UK Shared Prosperity Funding (UK SPF) for 24/25 (issued in April 2024). The UK SPF funding criteria has already been investigated and this funding could be used to support the proposed Scheme, such as funding benches, seating areas, tables, bins and planted areas.

Additional Considerations

· Discuss 'Deed of Easement' with landowners.

Next Steps

In order to prepare this report, District Councillor for Western Springs Olivia Lyons has already discussed the feasibility of any new Scheme with officers from Rugeley Town Council and the Property Services and Corporate Assets Team at Cannock Chase District Council.

Confirmation has been sought in respect of the next steps and the permissions required, which are as follows:

- Consideration be given to the request for a contribution of £35,000 by the Cabinet at Cannock Chase District Council.
- Rugeley Town Council investigate additional funding and grant opportunities (if required).
- Submit that Scheme proposal for approval from 3 parties:
 - Approval from CCDC as they adopted previous boardwalk (the Property Services Department at CCDC would then seek approval from other internal departments, including legal);
 - Approval from any associated landowners (as the right of access may need to be renegotiated); and
 - Approval and sign off from the Environment Agency who are responsible for the watercourse and brook.
- Seek exact measurements (specification) for the proposed new bridge to enable further quotes to be sought.
