48 Council Vacancies and Co-option

The council currently has four vacancies.

There are two vacancies for which an election has not been called, so the council needs to decide on the time scales for co-opting as per the Co-option policy attached.

I have already had two applications for these vacancies which are on file (C Martin and Dave Lucas.

Council to consider the timescale for accepting applications from persons interested in being co-opted in line with the Co-option Policy

The other two vacancies on the council are currently being advertised. The first one closes on 2nd May and the second on 16th May. After these dates the council will know if an election has been called. If no election has been called, the council will then need to consider co-option to these two vacancies.

49 Policies for Adoption

Recruitment and Selection – this was considered by the F&M committee, and they recommended this for adoption, but would be reviewed when the Town Council HR review is undertaken

Councillor Induction Policy - I have updated this as previously requested by the Council. I ran an induction session which was attended by two of our new councillors and two of our existing councillors last week. The only outstanding item is to arrange for the new councillors to visit the office for a tour and meet the staff. Perhaps this can be arranged after all vacancies on the council are filled.

50 Bank Mandates for Lloyds, Unity Trust, CCLA and LDD accounts

I have been in contact with all of the above on 25th April, with mixed results

Lloyds account – on line access

They now have the necessary approvals for the removal of seven people from online access and this should e processed within a few days. The people are:- G Grant; N Mahon; C Martin; C Green; H Goodreid; K Roberts or N Stanley and R Dipple. Fingers crossed

Lloyds account – signatories

The following people are still able to sign as of today:- R Dipple, G Grant; C Green; N Mahon and C Martin. It's interesting to note that when David and I both spoke to the bank about getting approval for removal of the online access above, they told us only David and Pat could approve. The bank cannot explain why this differs to the number of people on the account

I have emailed our relationship manager again today, to see what's happening but have done a new mandate change form and hope this will work

Lloyds accounts – outstanding actions

Daniel Foceac still to be added as a signatory – form has now been done

Lloyds accounts – new actions to take

Remove Angi Cooney as a bank signatory

Remove Neil Stanley as a bank signatory and an on line access user Remove Sue Buxton as bank signatory and on line access user Change correspondent from S Buxton to M Matthews Check that both Kate Roberts and Neil Stanley have been removed from on line access, as bank only took 7 off, and there are 8 names Signatories on the account will be D Gaye; P Ansell and D Foceac whilst online users will be D Gaye, G Kirkham, D Foceac (still waiting for his card etc – application sent with GKs but not sent out with GKs) and M Matthews.

One or two additional signatories and the same for online access need to be considered

Council to consider and approve the removal of A Cooney, N Stanley and S Buxton as detailed above; to change the correspondent from S Buxton to M Matthews; to check that both K Roberts and N Stanley have actually been removed and consider if additional users need to be added.

Unity Trust

The signatories are: C Green; G Grant; R Dipple; K Roberts; S Buxton; N Stanley, A Cooney and H Goodreid is the main contact and M Matthews has view only access.

Form has now been done to remove R Dipple; G Grant; H Goodreid; K Roberts and already agreed

Unity Trust – outstanding actions None

 Unity Trust – new actions to take, requiring council approval Remove C Green, and N Stanley Remove Angi Cooney and Sue Buxton from the account, when the above changes have been actioned, otherwise it will be impossible to operate the account

Change M Matthews to full access and correspondent Signatories on the account will now be S Buxton, A Cooney and M Matthews, council needs to add at least three more signatories before the removal of S Buxton and A Cooney

Council to consider and approve the removal of C Green and N Stanley, the eventual removal of A Cooney and S Buxton, changes to the access of M Matthews and three additional signatories

CCLA

Current signatories are:- S Buxton; M Matthews; K Roberts; I Hodgson – form now done to remove; C Green – form now done to remove and N Stanley.

Council has already agreed to add K Hart and D Foceac – form done awaiting signature from D Foceac.

Only S Buxton has online access, and has now added all of the existing users

Council to consider and approve the removal of K Roberts and N Stanley as signatories, add M Matthews as main Admin contact and correspondent and remove S Buxton as correspondent and main Admin contact.

LDD Account

Current signatories are:- R Dipple; H Goodreid and N Mahon and the council has already agreed to change remove all of these and add K Hart, R Hughes and S Buxton, who would also been the correspondent. Form has been done without adding S Buxton. Online banking access has not been arranged but is required as no cheque book is held Council needs to add M Matthews instead of S Buxton as signatory and correspondent

Council to consider and approve the replacement of S Buxton with M Matthews as both a signatory and correspondent and to grant all three signatories online banking access

51 Rose Theatre roof repairs

The Rose Committee has looked at quotations from builders for repairs to the roof over the plant room about the Landor suite. They recommended the first quote at £2,500 subject to agreement from CCDC re: lease, confirmation of guarantee and sight of the terms and conditions. This have all been concluded successfully.

Full council were given the opportunity to approve this request by emailing the clerk – **7** emails required, but only one was received

Council action dependent on response to email from the Clerk. Either.-

- Ratify decision made by councillors via email for the work to go ahead, OR
- Confirm agreement to go ahead with the works at a cost of £2,500 as recommended by the Rose Committee

52 Air Conditioning

The air conditioning has been serviced and there are some items identified as requiring attention. No alternative quotes requested for this as the company was selected for the annual maintenance at an earlier meeting and this is the continuation of the work they are already contracted for. The F&M Committee has recommended that these repairs be undertaken.

Council to consider ratifying the recommendation for the work to repair the air conditioning
